#### Presentation: LGBT Center, Jae O'Dougherty

Jae O'Dougherty (<u>iodougherty@lalgbtcenter.org</u>) provided a presentation (slides attached) on resources and programs from the Los Angeles LGBT Center

- LA LGBT Center:
  - Youth Services: Focused on LGBTQ+ youth but open to all youth who identify as allies
    - Offer emergency overnight housing program
    - Offer short term residential housing (50 beds), up to 1 year of housing provided
    - A variety of additional supports are available such as education, employment, mentoring, youth development (quality of life), etc.
  - Senior Services: Offer 200 programs/month for seniors: social connectedness
  - Children/Youth/Family Services:
    - Rise (Recognize, Intervene, Support, Empower)
      - www.rise.lalgbtcenter.org
      - CEU provider, distance learning and e-coaching
      - Menu of 30+ unique trainings and workshops
      - Models of Pride Oct. 19 LACC

- Largest LGBTQ+ conference offering safe spaces for youth and adults
- Offer trainings on LBGTQ+ cultural competency trainings through
  - Various trainings: from brief basic trainings, 6 hour, or five day trainings
- Provided background and context on SOGIE (Orientation, Gender Identity, and Gender Expression)

### **Discussion: District Suicide Prevention Activity Survey**

Stan Collins shared an update regarding on the survey that was sent to all Los Angeles County districts. The purpose of the survey is to identify district's responses to AB2246 (Ed Code 215). The survey will be used as a tool for system mapping as well as to identify needs of districts regarding prevention, intervention and postvention supports.

- o Approximately 45 of the 80 districts who received the survey have responded.
- Workgroup members are encouraged to reach out to contacts within districts to request survey completion
  - A template email will be sent to workgroup members to facilitate requests
