- Impact of social media use on youth mental health
- Parent and school monitoring programs for emails, texts, social media, and school-issued devices
 - Monitoring focuses on self-harm, suicidal ideation, acts of violence, cyberbullying, sexting, online predators, etc.
- Goals:
 - Foster digital citizenship
 - Monitor, identify and intervene before catastrophe
- "Bark for Family" version: \$9 per family per month
 - Monitoring for over 25 social media platforms and apps
- Bark for Schools: FREE for schools
 - Monitoring system for school-issued devices
 - Web filter and monitoring services

- Also includes human monitoring for small percentage of posts that need higher level of analysis

Updates (60 min):

- Youth Suicide Prevention Workplan Stan Collins
 - LASPN District Survey
 - An update was provided on the status of the county-wide district survey.
 - 75% of districts in Los Angeles County responded and completed survey
 - Based on survey feedback, schools identified specific interests and needs for support including responding after a suicide, risk assessment and safety planning, engaging students and parents, and training for staff as primary needs.
 - Discussion surrounded need to support schools in risk assessment and referral processes. The workgroup is in development of a "template risk assessment packet" to respond to this need.

 - An update was provided on the status of the "template risk assessment packet" covering what items will be included and the review process for workgroup members to provide input.
